- December 23, 2011** Last day to post and publish notice for first public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code if a second public hearing is anticipated.
- January 3, 2012** Last day to hold first public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code if a second public hearing is anticipated.
- January 6, 2012** Last day to post and publish notice for final public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code.
- January 17, 2012** Last day for Planning Board to hold final public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code. Planning Board must also determine final form.
- February 4, 2012** Earliest date to hold First Session of town meeting - latest date is February 11, 2012.
- February 7, 2012** Last day for official copy of final proposal to amend zoning ordinance, historic district ordinance or building code to be placed on file at the town clerk's office.
- February 11, 2012** Last day to hold First Session of town meeting.
