

IMPORTANT DATES FOR TRADITIONAL TOWN MEETINGS (MARCH MEETING)

November 9, 2009	First day to accept petitions to amend zoning ordinances, historic district ordinance or building code.
December 9, 2009	Last day to accept petitions to amend zoning ordinances, historic district ordinance or building code.
January 8, 2010	Last day to post and publish notice for first public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code if a second hearing is anticipated.
January 19, 2010	Last day to hold first public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code.
January 22, 2010	Last day to post and publish notice for final public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code.
February 2, 2010	Last day for Planning Board to hold final public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code. Planning Board must also determine final form.

January 11, 2010	First day to accept petitions to amend zoning ordinances, historic district ordinance or building code.
February 10, 2010	Last day to accept petitions to amend zoning ordinances, historic district ordinance or building code.
March 12, 2010	Last day to post and publish notice for first public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code if a second hearing is anticipated.
March 23, 2010	Last day to hold first public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code.
March 26, 2010	Last day to post and publish notice for final public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code.
April 6, 2010	Last day for Planning Board to hold final public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code. Planning Board must also determine final form. Last day for official copy of final proposal to amend zoning ordinance, historic district ordinance or building code to be placed on file at the town clerk's office.

November 9, 2009	First day to accept petitions to amend zoning ordinances, historic district ordinance or building code.
December 9, 2009	Last day to accept petitions to amend zoning ordinances, historic district ordinance or building code.
December 25, 2009	Last day to post and publish notice for first public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code if a second public hearing is anticipated.
January 5, 2010	Last day to hold first public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code if a second public hearing is anticipated.
January 8, 2010	Last day to post and publish notice for final public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code.
January 19, 2010	Last day for Planning Board to hold final public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code. Planning Board must also determine final form.
January 30, 2010	Earliest date to hold First Session of town meeting - latest date is February 6, 2010.
February 2, 2010	Last day for official copy of final proposal to amend zoning ordinance, historic district ordinance or building code to be placed on file at the town clerk's office.
February 6, 2010	Last day to hold First Session of town meeting.
March 2, 2010	Last day to submit protest petition to require 2/3 vote at town meeting.

December 14, 2009	First day to accept petitions to amend zoning ordinances, historic district ordinance or building code.
January 13, 2010	Last day to accept petitions to amend zoning ordinances, historic district ordinance or building code.
January 22, 2010	Last day to post and publish notice for first public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code if a second public hearing is anticipated.
February 2, 2010	Last day to hold first public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code if a second public hearing is anticipated.
February 5, 2010	Last day to post and publish notice for final public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code.
February 16, 2010	Last day for Planning Board to hold final public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code. Planning Board must also determine final form.
February 27, 2010	Earliest date to hold First Session of town meeting – latest date is March 6, 2010.
March 6, 2010	Last day to hold First Session of town meeting.

January 11, 2010	First day to accept petitions to amend zoning ordinances, historic district ordinance or building code.
February 10, 2010	Last day to accept petitions to amend zoning ordinances, historic district ordinance or building code.
February 19, 2010	Last day to post and publish notice for first public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code if a second public hearing is anticipated.
March 2, 2010	Last day to hold first public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code if a second public hearing is anticipated.
March 5, 2010	Last day to post and publish notice for final public hearing on proposed amendment to zoning ordinance, historic district ordinance or building code.
March 16, 2010	Last day for Planning Board to hold final public hearing on propose amendment to zoning ordinance, historic district ordinance or building code. Planning Board must also determine final form.
April 3, 2010	Earliest date to hold First Session of town meeting - latest date is April 10, 2010.
April 6, 2010	Last day for official copy of final proposal to amend zoning ordinance, historic district ordinance or building code to be placed on file at the town clerk's office.
April 10, 2010	Last day to hold First Session of town meeting.
May 4, 2010	Last day to submit protest petition to require 2/3 vote at town meeting.
May 11, 2010	Second Session of annual town meeting to vote on all warrant articles from First Session of annual town meeting.
