### SWRPC Launches Housing Survey for Employers

As part of SWRPC's Regional Housing Needs Assessment, a survey has been developed for employers to gauge how the local and regional housing market affects their business. Early data collected by SWRPC suggests that a significant proportion of employers believe that a housing shortage has affected their ability to recruit and retain workers, however, the survey sample at this time remains small. In an effort to gather a larger survey sample of employers, SWRPC seeks assistance in spreading the word about the survey. The goal is to better understand employer's perceptions of the housing market in the Region as well as attitudes about the connection between housing and business growth. ### Transportation Plan Updates

During the month of March SWRPC participated in meetings with the New Hampshire Department of Transportation (NHDOT) regarding its plans to update the *NH State Rail Trails Plan* (last updated in 2005) and the *NH Statewide Pedestrian and Bicycle Transportation Plan*, both of which are scheduled to be finalized in 2022. SWRPC staff comments have focused on ensuring that the documents are user friendly and that the plans are realistic, feasible, and reflect local and regional priority needs and issues that staff has become aware of in day-to-day communications with member towns and other relevant stakeholders. Both policy documents seek to more broadly define funding opportunities for implementing projects, provide policy guidance recommendations on priority project selection and identify project priorities - all of which are improvements that are likely to enhance transparency and better coordination among different state and federal funding programs administered by NHDOT and other State agencies. ### Monadnock Broadband Group



## Age-Focused Planning: Social and Recreational Resources

Social engagement and recreational opportunities are critical to retaining and attracting a diverse population and promoting public health. Did you know that the average number of hours per day spent socializing by U.S. residents is declining across all age categories? The greatest declines are occurring among the 15-24 and 65+ age groups (declines of 23.8% and 21.8%, respectively between 2003-2018). Fortunately, Southwest New Hampshire offers many opportunities for social engagement and recreation; however, the lack of awareness of these opportunities prevents people from participating. SWRPC is developing an inventory of resources in support of social engagement and recreation.
