## **Monadnock Community Power Roundtable**

On June 7<sup>th</sup>, SWRPC and the Monadnock Sustainability Hub (MSH) hosted a Monadnock Community Power Roundtable at the Keene Public Library. Community Power, authorized by NH RSA 53-E, enables towns, cities and counties to choose sources and providers of electricity on behalf of residents and businesses, work with utilities on local energy infrastructure upgrades and provide electricity supply rates and services to all customers participating in the program. The Roundtable recognized establishment of community power plans in Harrisville, Keene, Marlborough, Peterborough, Swanzey, Walpole, and Cheshire County, and provided an opportunity to share lessons learned with others considering Community Power. Over thirty people attended the event including stakeholders from Chesterfield, Dublin, Nelson, Jaffrey, and Westmoreland. SWRPC and MSH plan to hold additional events in the coming months. # **NH 9 West Corridor Public Meeting**

As part of the update to *Southwest Connects*, the Regional Transportation Plan for Southwest New Hampshire, SWRPC will host the first of eight public meetings over the coming months on **July 12, 2022 at 6:30 p.m**. Each meeting will focus on a corridor system featured in the Plan, with the first being the NH 9 West Corridor - a subregion comprising Chesterfield, Hinsdale and Keene. The Corridor's main feature is NH Route 9 from Keene to Brattleboro, VT, and also includes NH Route 63, NH Route 9A and NH Route 119. Other assets such as the Chesterfield Gorge Park and Ride lot and the Fort Hill Branch rail trail are considered part of the Corridor system. At the meeting, SWRPC staff will present data and information about the Corridor to be followed by open discussion, ideas and feedback among attendees. #### Pavement Preservation Plan in the Town of New Ipswich

During June, SWRPC completed a Pavement Preservation Plan for the Town of New Ipswich utilizing Road Surface Management System (RSMS) guidance, protocols and forecasting software offered by the UNH Technology Transfer Center and NH Department of Transportation. RSMS is a data-driven approach to managing roads using recent road condition data and applying the principals of pavement preservation. Undertaking the RSMS process that helps towns extend pavement life at a cost savings systemwide. This project involved a field inventory of pavement conditions on all Town-maintained roads and an analysis that examined projected future road conditions and repair costs. Using this information, as well as input from local officials, SWRPC created a 10-year plan that will assist the Town in planning for future pavement maintenance.
