The National Telecommunications and Information Administration's <u>Broadband Equity, Access, and Deployment (BEAD) Program</u>, provides <u>\$196.6 million</u> to expand high-speed internet access in New Hampshire. The State's Office of Broadband Initiatives and Mission Broadband (the State's contractor) recently announced public review and comment periods for their Initial Proposal document, Volume I and Volume II tied to this funding. Staff from Mission Broadband will provide an overview of the different BEAD-related documents, accept input from attendees, and answer questions.



DRAFT DIGITAL EQUITY PLAN

In tandem with the development of documents related to BEAD, the State's Office of Broadband Initiatives has overseen the development of the first ever Digital Equity Plan by the University of New Hampshire Cooperative Extension (UNHCE) and the National Collaborative for Digital Equity (NCDE). Project partners established a website for the initiative (nhdigitalequity.org) and conducted various surveys and discussions over the course of the development of the Plan. Following the November 13th Digital Equity Summit, staff from UNHCE and NCDE will provide an overview of New Hampshire's 4-year plan for digital equity in support of economic, educational and other opportunities.
