Broadband Connectivity and Digital Equity

On December 13th, SWRPC submitted comments to New Hampshire's Office of Broadband Initiatives about their plans for \$196.5 million in broadband infrastructure funding through the National Telecommunications and Information Administration (NTIA) relative to the Broadband Equity Access and Deployment (BEAD) program. SWRPC's comments focus on the importance of connectivity with community anchor institutions, improvements to performance measurement and addressing digital equity. New Hampshire Rural Technical Assistance Program Training

The New Hampshire Rural Technical Assistance Program (NHRTAP), which provides driver and management-level training, technical assistance, and scholarship assistance to rural transit providers in New Hampshire, is offering a series of training sessions in January. Topics include passenger assistance Techniques, disability awareness, defensive driving, and emergency procedures and evacuation. The NHRTAP assists New Hampshire's rural public transit systems in providing safe and effective service through training programs, the NHRTAP newsletter and website at https://www.newhampshirertap.com/, and one-on-one technical assistance. Transportation Infrastructure Vulnerability Assessment

SWRPC staff kicked-off work on the region's first-ever vulnerability assessment of transportation infrastructure. The assessment will focus on precipitation-related impacts to publicly owned roads, bridges and culverts. The project will use the Federal Highway Administration's Vulnerability Assessment Scoring Tool to organize and weight many factors including asset condition, age, flood history, and damage potential. This effort will utilize information about climate and weather hazards relevant to transportation infrastructure from the New Hampshire Climate Assessment (2021) as well as identify both short-term and long-term strategies and projects to address vulnerable infrastructure. Food System Planning

On December 11th, SWPRC staff and the Food Systems Work Group of the Monadnock Farm and Community Coalition, helped to facilitate a focus group discussion on sourcing goods locally. The goal for the event was to bring Monadnock Region restaurants, value-added producers, grocers, and other entities together to discuss opportunities and challenges for sourcing products locally. Highlights of the discussion included success stories from businesses who work to develop partnerships with other regional businesses, a conversation about the logistical challenges with distribution in a rural region and brainstorming of projects and funding opportunities that could help enhance the resilience of our local food system. The discussion will help inform several ongoing efforts, including SWRPC's regional food system assessment.
