Keene Housing Celebrates Grand Re-opening of 105 Castle Street Center

On March 6th, Keene Housing hosted an open house to celebrate the grand re-opening of its 105 Castle Street facility in Keene. The building was rebuilt from the foundation after a March 2021 fire caused extensive damage. The facility serves as the heart of the Harper Acres housing development which contains 112 apartments and houses over 120 low-income residents, the majority of which are elderly and/or those with disabilities. As the only indoor public space in the complex, 105 Castle Street provides laundry facilities, access to services and a social gathering space. The NH Care Collaborative (NHCC), a non-profit organization which provides support services to elderly and disabled persons and their caregivers in Southwest New Hampshire, is conveniently located within the building.

The rebuilt facility provides community space, new and improved office space for the NHCC, a kitchen, updated laundry facilities, enhanced accessibility features, and energy efficiency improvements. Funding for the \$3.3 million project included a \$900,000 Community Development Block Grant awarded by the NH Community Development Finance Authority. Electric Vehicle Infrastructure Survey

The New Hampshire Department of Transportation (NHDOT) and the New Hampshire Department of Environmental Services (NHDES) are considering a joint funding proposal for electric vehicle (EV) charging infrastructure through the federal Charging and Fueling Infrastructure program (CFI). To inform a potential proposal, New Hampshire's regional planning commissions are assisting by compiling a list of candidate sites for locating charging infrastructure. SWRPC is seeking survey responses to better inform our efforts with respect to locating EV charging infrastructure and to support this potential statewide funding opportunity.
