

# General Cybersecurity Training Overview

## Purpose:

This training provides foundational knowledge and practical guidance on cybersecurity best practices, threats, and risk mitigation strategies tailored specifically to the educational or municipal environment. It aims to equip participants, with all levels of technical expertise, with the essential skills and awareness necessary to safeguard sensitive data, protect critical infrastructure, and mitigate cyber threats effectively.

## Audience:

### All Public Sector Employees (all levels)

This training is designed for a diverse range of stakeholders within schools or municipal administrations, such as administrators, educators, IT personnel, support staff, and other employees who handle sensitive information or have access to digital systems. Additionally, this training may also be relevant for school board members, municipal councilors, and other leadership roles responsible for setting policies and allocating resources related to cybersecurity.

- 4. Ransomware Tactics:** Explore the techniques used by ransomware attackers and effective methods for defending against and responding to ransomware incidents.
- 5. Protecting Yourself and Your Entity:** Receive practical guidance on personal cybersecurity hygiene and best practices for securing digital assets and information.
- 6. Data Privacy:** Learn about data privacy regulations and best practices for protecting sensitive information in compliance with legal requirements and industry standards.
