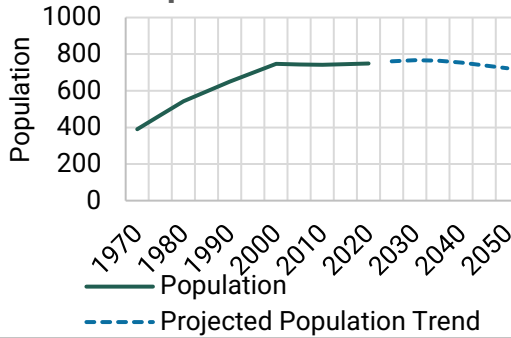

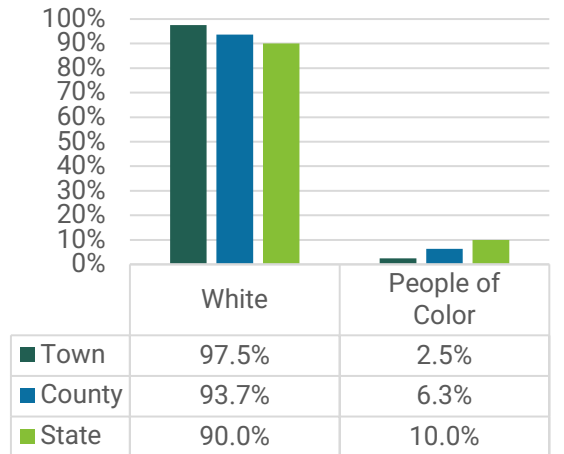

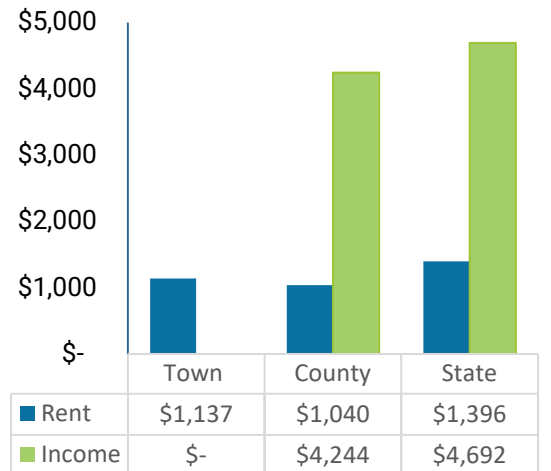

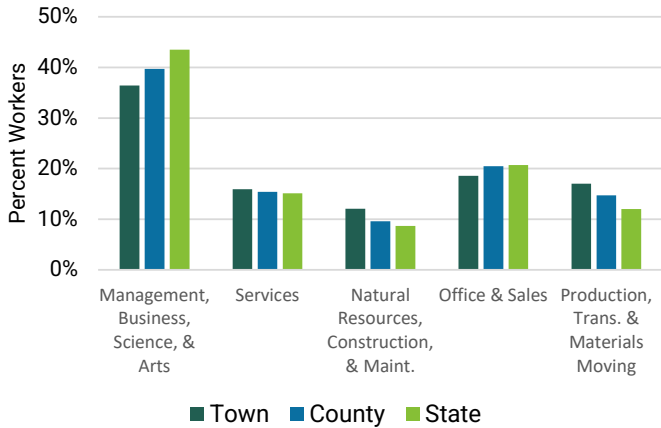

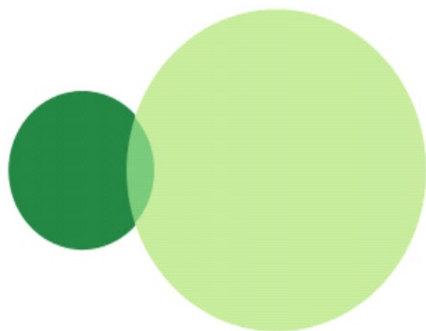

All Workers

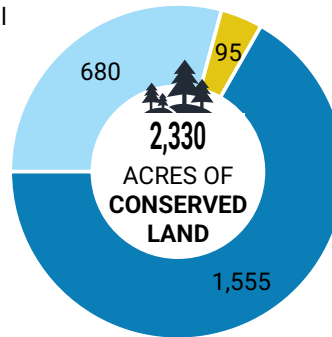

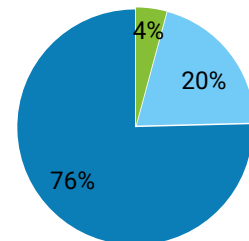
