# **Transportation Advisory Committee Evaluates Regional Priority Projects**

On October 7<sup>th</sup>, SWRPC's Transportation Advisory Committee (TAC) listened to presentations on four projects competing for inclusion in the 2027-2036 Ten Year Transportation Improvement Plan. The New Hampshire Department of Transportation (NHDOT) has set aside approximately \$5 million in federal funds to construct one or more SWRPC regional priority projects in 2036 and 2037. Projects include proposals to improve walking and cycling infrastructure between Hinsdale and Brattleboro, VT; a proposal to improve the NH Route 12 and NH Route 32 intersection in Keene; a proposal to address intersection and pedestrian safety concerns and inadequate stormwater infrastructure on NH Route 101 and NH Route 124 in Marlborough; and a project to build out a network of sidewalks and crosswalks on NH Route 12, NH Route 32 and Lake Street in North Swanzey. The TAC is scheduled to review and discuss its initial scoring results at its meeting on November 4<sup>th</sup>, after a ranked list will be submitted to NHDOT for review and comment. ## **Citizen Planner Peer-to-Peer Roundtable**

SWRPC and the Monadnock Resource Alliance held a Peer-to-Peer Roundtable event for planning board members for towns in the Monadnock Region. Representatives from Alstead, Marlow, Sullivan, Gilsum, Harrisville, Dublin, Fitzwilliam, Temple, and Greenville attended. A Rose-Bud-Thorn discussion method highlighted recent successes, upcoming projects, and current challenges. Roses included migrating documents to digital storage platforms, ADU ordinance amendments, consistent communication with town officials, routine ordinance maintenance, and development of planning board rules and procedures. Buds included master plan updates, planning board member education, and increasing public participation. Thorns mainly surrounded resource management - be that time, people, or funds and the disproportionate burden rural towns feel about documentation. The federally funded Transportation Alternatives Program (TAP) is designed to provide choices for nonmotorized users that are safe, reliable, and convenient. New Hampshire Department of Transportation's Round 5 of the program is now available at <u>bit.ly/3YuPB2D</u>. Interested applicants must complete a non-binding *Letter of Interest Form* by **Friday, December 6, 2024** with applications due by **Friday, January 24, 2025**. Local governments, schools, non-profits and others are eligible to apply for projects like bicycle and pedestrian facilities, safe routes to school projects, and vulnerable road user safety assessments. The Monadnock Region Accessory Dwelling Unit Design Challenge requests conceptual ADU design submissions from architects and building designers, students, and community members in the Monadnock Region, state of New Hampshire, and New England area. Three \$5,000 prizes will be awarded: one for each category of ADU (new attached addition, new freestanding structure, adaptive reuse of an existing structure).
